

Patient Choice Letter - Home Health Services

Dear Patient:

Your physician is recommending that you receive follow up care at a **Home Health Agency**. The Centers for Medicare and Medicaid Services (CMS) require hospitals to proved patients with a list of Medicare-participating home health agnecies that serve the geographic area requested by the patient (you) to help you make an informed choice of provider. As the patient, you (or your legal representative) have the right to choose which home health agency you want that can meet your services needs upon discharge. Mercy Medical Center will do out best to honor your preferences; however, please note referral is not limited to selected agency. Should your preferred agency be unable to accommodate the request, services at alternate agency may be necessary to continue treatment at the appropriate level of care.

CMS also requires that the hospital disclose to you its ownership/interest in any home health agency included on the attached list. Dignity Health has ownership interest in the following home health agency:

Please be advised that <u>if</u> you are enrolled in a Managed Care Insurance plan (HMO), your insurance only covers home health services which are preauthorized and provided in a contracted Home Health Agency. Please check with your insurance company if you are uncertain about your options for Home Health Services. Please see the list on the back of this letter so that you can make an informed decision. Agencies listed in **bold** are those that are part of the Dignity Health family and/or have demonstrated higher levels of quality. Also please note you may have a copay/deductible associated with this service. Contact your insurance company for more information. A member of Care Coordination is available should you have any questions.

Home Health Compare was created through the efforts of the Center for Medicare & Medicaid Services (CMS), an agency of the U.S. Department of Health and Human Services (DHHS). NOTE: Medicare won't cover home health services provided by a home health agency that hasn't been Medicare-certified.
