

The Dignity Health Community Grants Program is funded by contributions from our member hospitals. In awarding community grants, Dignity Health actively partners with non-profit organizations working to improve health status and quality of life in the communities we serve.

Grant funds are used to deliver services and strengthen service systems, to improve the health and well-being of vulnerable and underserved populations. The program is one way Dignity Health puts its mission and values into practice.



Funding Criteria

The Community Grants Program uses funding criteria to ensure that its charitable resources address health needs in ways that demonstrate accountability for impact. Grant applicants should ensure that their proposed projects:

- Address one or more prioritized significant needs in the local hospital's Community Health Needs Assessment (CHNA) and Implementation Strategy.
- Proposals addressing needs exacerbated or created by the coronavirus pandemic (including physical or mental health, and health-related social, economic and human needs) will be considered.
- Serve identified vulnerable or underserved populations, to help address health disparities.
- Include three or more collaborating organizations (an "Accountable Care Community") with distinct, complementary and substantive project roles.
- Work in some capacity with the local Dignity Health hospital.
- Integrate one or more of the following principles:
 - Focus on disproportionate unmet health-related needs in priority areas such as health behaviors, mental health services, limited access to healthy foods and children in poverty;
 - Emphasize primary prevention and address underlying causes of health problems;
 - Contribute to a seamless continuum of care;
 - Build community capacity; and
 - Demonstrate collaboration.
- Identify – and plan to evaluate and report on – specific and measurable outcome goals.

Eligibility and Parameters

- Lead applicant organization collaboration must be a 501(c)(3) non-profit organization.
- Grant project awards are from \$20,000 up to \$60,000 at the discretion of the hospital.
- Grant project performance period is 12 months from January 2022 – December 2022.
- Projects can serve specific community and/or patient populations.
- Mid-year and final written reports are required.

Application Process

1. Review the prioritized significant needs in Yavapai Regional Medical center's CHNA report and Implementation Strategy (Download from: <https://www.yrmc.org/support-and-community/community-health>).
2. Prospective applicants are encouraged to contact the Grant Representative to inquire about specific funding priorities. Proposals addressing needs exacerbated or created by the coronavirus pandemic (including physical or mental health, and health-related social, economic and human needs) will be considered, in addition to those addressing needs in a hospital's community health needs assessment.
3. Request a Project Proposal Form from the Grant Representative.
