2. Prospective applicants are encouraged to contact the Grant Representative to inquire about specific funding priorities. Proposals must address one or more significant health needs in the hospital's Community Health Needs Assessment and Implementation Strategy, and/or needs exacerbated or created by the coronavirus pandemic (including physical or mental health, and health-related social, economic and human needs).

PROGRAM OVERVIEW

Dignity Health's 2023 Community Health Improvement Grants program focuses on collaboration with an emphasis on responding to significant health needs identified in the Community Health Needs Assessment. The goal of the program is to develop strategic partnerships between community-based organizations that link services directly to Dignity Health's Woodland Memorial Hospital; leveraging resources that address priority health issues, and utilize creative strategies that have a direct, positive and lasting impact on the health of disadvantaged individuals and families in our community.

PRIORITIES

Listed below are the top 5 ranked significant health needs in order of priority for Yolo County. The remaining priority needs can be located in the most current CHNA.

1. Access to Basic Needs Such as Housing, Jobs, and Food
2. Access to Mental/Behavioral Health and Substance Use Services
3. Injury and Disease Prevention and Management
4. Active Living and Healthy Eating
5. Access to Quality Primary Care Health Services

PROGRAM REQUIREMENTS

1. To be eligible for funding in this year's grant cycle, organizations must:
 - a. Be a 501(c)3 organization (e.g., community health centers, FQHCs, non-government run FQHC look-a-likes, faith-based centers, family resource centers, other community-based organizations and faith-based organizations)
 - b. Work in collaboration with a minimum of 3 organizations
 - c. Program/Project responds to two or more of the stated priority health needs
2. Programs must show direct linkage to Dignity Health hospital(s)
3. Partnership requirements:
 - a. Must establish a meaningful and viable partnership with strategic alignment as evidenced by:
 - i. a mechanism for shared decision-making and authority
 - ii. partners serve the same community
 - iii. partners have compatible missions
4. Programs must provide services within Yolo County

CRITERIA

1. Funding is for a minimum of \$20,000 up to \$100,000 per collaborative proposal.
2. Projects must include target population identified in one or more of the following focus communities:
