Visitor Guidelines



Effective November 30, 2022, our visitation guidelines have been updated.

- All visitors to the hospital must be 18 years of age or older and present one form of legal photo identification, preferably a Driver's License.
- All visitors will screen themselves for COVID-19 symptoms upon entry and check in and out at the front entrance Security desk. Visitors who are symptomatic for COVID-19 may not enter the hospital at this time.
- Visitors must wear a mask in accordance with the hospital masking policy at all times while in the facility. Visitors are expected to go directly to the patient's room and stay with the patient until the visitor departs from the hospital.
- We encourage patients and families to coordinate visitation. Please keep in mind the hospital lobby and waiting areas are restricted.
- Visitors must check out with security upon departure from the facility to turn in their visitor badge.
- Patient Belongings / Deliveries to Patients: Deliveries to patients cannot be dropped off at this time. Personal effects needed for the patient's care or comfort should be brought by a visitor.
- **Food Deliveries:** Visitors may receive food deliveries to the hospital through the main entrance. Visitors must make all arrangements to receive the order directly from the delivery person in front of the hospital. Food deliveries may not be dropped off, and hospital staff cannot assist in food deliveries.
- Visiting Hours are between 5:00AM 8:00PM

COVID-19	Adult patients with a current/active case of COVID-19 may have 2 visitors per day. Once visitors leave for the day, they may not return until the following day.
Patients under the age of 18	One parent/guardian is welcome at all times and a second visitor is welcome daily. Pediatric patients who are positive for COVID-19 may have a parent/guardian with them at all times; visitors will be required to wear the designated PPE and must stay in the room with the patient.
NICU	Two parents/guardians may visit, or one banded parent/guardian may visit accompanied by a grandparent or other approved family member 18 years old or older. NICU visiting hours are 5:00AM to 10:00PM.
Labor and Delivery	Patients may designate 2 support persons to be present through delivery.
Postpartum Care	Two support persons may stay with the patient through discharge.
General Inpatient/Nursing Units (including ICU)	Patients may welcome 2 visitors at a time. Extended and overnight visitation is dependent on the patient's condition and will be evaluated on a case by case basis.
Procedural Areas	Visitors may not wait inside the hospital during procedures at this time. Outpatient visitors may stay with the patient until the patient is taken to pre-op and return for pickup upon discharge.
Emergency Department (ER)	Adult patients in the Emergency Department are allowed one visitor. Lobby patients are unable to have a visitor due to social distancing requirements.
Patients with Physical, Intellectual, and/or Developmental Disabilities and/or Cognitive Impairments	Two visitors at a time are welcome. When continuous care is necessary, a visitor may stay overnight with approval.
Clergy	Clergy are welcome to visit patients as requested by the patient or their family. If after hours, a notice to the hospital chaplain prior to the visit is appreciated. If the patient is end of life and COVID +, clergy need approval. Clergy is not considered a visitor in acute health care.
Patients near Death	2 people may remain with the patient at a time through end of life. Requests for end-of-life visitation with a COVID-19 positive patient may be considered on a case by case basis.
Clinic Appointments	Patients can have 1 healthy companion.
